**Entry Fee:** \$180 / Dog. **Commission:** 6%

**Entries Close:** Monday 9<sup>th</sup> October 2017 – NO EXCEPTIONS. Entries by phone /fax, and without entry fee will not be accepted.

## Conditions of Entry:

1. Vendor trial Sheep/Cattle is open to dogs entered into the Auction. The dog must be sold in the sale to be eligible to receive prize money.
2. Vendors will receive a free entry into Open Trial's per dog offered. Non sale vendors / competitors will attract a \$30 entry fee to compete in Open Trial.
3. Single entry fee entitles dogs to compete in both sheep/cattle arenas.
4. A ranking sheet and entry details must be supplied for every dog entered.
5. Dogs must be entered in both sheep/cattle trials to be demonstrated in both sheep/cattle arenas.
6. Entry forms must be accompanied with (a) 2 minute working video (b) vaccination certificate (c) registration certificate / pedigree papers
7. All dogs **must demonstrate working capabilities** on either sheep/cattle and be of good quality.
8. Video must be of good quality, supplied by USB stick or email. This is highly important as these videos are used to showcase your dog on an online catalogue
9. All dogs nominated **must** match the description submitted on the entry form. Colin Say & Co P/L & the RMA Network reserve the right to refuse any dog entry to the auction and reject uncontrollable dogs or dogs of inferior quality or dogs endangering stock.
10. If a dog is judged to be not of the description provided on the entry form then the committee may change the dog's ranking or remove it from the auction. If a dog is rejected from the auction, no entry fees will be refunded.
11. Biting dogs (sheep) will be asked to be muzzled or withdrawn from auction.
12. Handlers **must** demonstrate/sell in order.
13. Dogs nominated **cannot** be substituted or sold prior to sale. RMA hold **Sole Agency** from once dogs are nominated until 48hrs after completion of auction.
14. A maximum of 50 dogs will be accepted for the sale. Committee reserves the right to limit numbers if maximum numbers are surpassed.
15. Maximum 3 dogs per handler. Dogs **under 10 months** will not be accepted. A maximum of **1dog under 12 months** per vendor.
16. No bitches in oestrus permitted on ground. Entry fees will be refunded on presentation of vet's certificate.
17. Colin Say & Co P/L and the RMA Network reserve the right to change/alter any of these conditions to best suit the club, public image or vendor's needs.
