To affiliate your trial with the NSWYDA:

### BEFORE YOUR TRIAL

1. Complete and email or post us a signed **AFFILIATION APPLICATION** (included in this document), so we have all the information we need to promote your trial.
2. Pay the affiliation fee so your trial is covered by third party insurance for financial members
3. Email us your entry form, if you want entries in advance (We now have a standard entry form template you can use just ask the Secretary to email it to you)
4. Print out some membership forms (temporary and full) which can either be downloaded from our website or obtained from the secretary to take to your trial
5. Only those trials where a completed and signed affiliation form and payment have been received by the association prior to the commencement of the trial can be covered by the associations insurance.

### AFTER YOUR TRIAL

1. Complete and email us any signed memberships form and send us any fees collected
2. If it was a Championship Trial, also send us the \$2 levy for all entries except Local and Beginner
3. Post or email your trial results to our Point Score Officer. His details can be found on the results sheet on our website or the about us page

If you have any questions, please do not hesitate to contact me, otherwise we look forward to receiving your completed Application and payment ASAP to ensure that your trial is affiliated and promoted in advance.
